3. HAZARD IDENTIFICATION

EMERGENCY OVERVIEW:

SYMPTOMS OF OVER-EXPOSURE BY ROUTE OF EXPOSURE: The most significant route of occupational overexposure is contact with skin. The symptoms of overexposure to this product are as follows:

<u>INHALATION</u>: It is possible to breathe this material under certain conditions of handling and use (for example, during mixing or spraying in a confined area). Breathing small amounts of this material during normal handling is not likely to cause harmful effects. Breathing large amounts may be harmful.

<u>CONTACT WITH SKIN or EYES</u>: Contact with the eyes may cause slight transient (temporary) eye irritation. Corneal injury is unlikely. Prolonged or repeated skin contact may dry the skin. Symptoms may include redness, drying and cracking of skin. 4. FIRST-AID MEASURES



<u>UNUSUAL FIRE AND EXPLOSION HAZARDS</u>: Run-off from fire control may cause pollution. Keep fire-exposed containers cool with water spray to prevent rupture due to excessive heat. Other measures of toxicity include TDLo, the lowest dose to cause a symptom and TCLo the lowest concentration to cause a symptom; TDo, LDLo, and LDo, or TC, TCo, LCLo, and LCo, the lowest dose (or concentration) to cause death. BEI - Biological Exposure Indices, represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.
