3. HAZARD IDENTIFICATION

EMERGENCY OVERVIEW:

SYMPTOMS OF OVER-EXPOSURE BY ROUTE OF EXPOSURE: The most significant route of occupational overexposure is contact with skin. The symptoms of overexposure to this product are as follows:

<u>INHALATION</u>: It is possible to breathe this material under certain conditions of handling and use (for example, during mixing or spraying in a confined area). Breathing small amounts of this material during normal handling is not likely to cause harmful effects. Breathing large amounts may be harmful.

<u>CONTACT WITH SKIN or EYES</u>: Contact with the eyes may cause slight transient (temporary) eye irritation. Corneal injury is unlikely. Prolonged or repeated skin contact may dry the skin. 

<u>UNUSUAL FIRE AND EXPLOSION HAZARDS</u>: Run-off from fire control may cause pollution. Keep fire-exposed containers cool with water spray to prevent rupture due to excessive heat. 7. HANDLING and STORAGE

Other measures of toxicity include TDLo, the lowest dose to cause a symptom and TCLo the lowest concentration to cause a symptom; TDo, LDLo, and LDo, or TC, TCo, LCLo, and LCo, the lowest dose (or concentration) to cause death. BEI - Biological Exposure Indices, represent the levels of determinants which are most likely to be observed in specimens collected from a healthy worker who has been exposed to chemicals to the same extent as a worker with inhalation exposure to the TLV.
